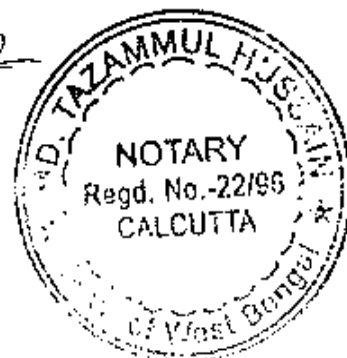


- 4) I hereby solemnly aver and undertake that

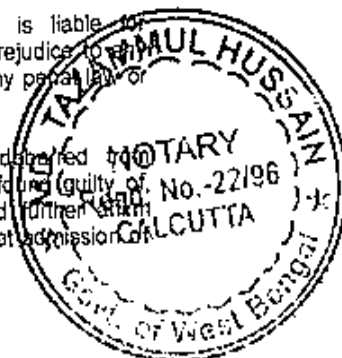




